Rome, July 8, sit-in of migrants in front of the Internal Ministry

WHY IS IT SO IMPORTANT TO GO TO ROME?

- The new government announced an amnesty for all the migrants who apply for the "quotas".

THIS IS NOT ENOUGH!

We do not want to be considered anymore as mere labour-force, we do not want to risk anymore to become illegal if we lose our job. **WE WANT A PERMANENT LEGALIZATION UNBOUNDED WITH WORK AND WAGE!**

- The new government announced that they will go "beyond", the detention centers, without closing them.

THIS IS NOT ENOUGH!

DETENTION CENTERS CANNOT BE IMPROVED, THEY MUST BE CLOSED, DEFINITELY! We do not want to be detained as criminals just because the Bossi_fini Law make us illegal!

- The new government announced his will of repealing the Bossi-Fini Law, and of returning to the "permesso di soggiorno per ricerca lavoro".

THIS IS NOT ENOUGH!

Till the link between labour contract and residence permit remains, everything will remain in the same way! **WE WANT TO BRAKE THE LINK BETWEEN LABOUR CONTRACT AND RESIDENCE PERMIT**, which give to patrons the power of deciding on our like and on our future! **WE WANT THE REPEAL OF THE BOSSI-FINI LAW, WITHOUT GOING BACK TO THE TURCO NAPOLITANO LAW!**

Therefore, we must to be all in Roma with migrants' and antiracist movements, on July the 8th, for the first big sit-in of migrants against the Bossi-Fini law, in front of the Internal Ministry.

LET'S START TO REPEAL THE BOSSI-FINI LAW

RIGHT NOW!

Migrants' and antiracist movement which has been protagonist of the struggles that took place in the last years, and of the big demonstration of December 2004 and 2005, does not recognize the inspection commission about detention centres instituted by the Internal Ministry in the perspective of "going beyond" detention centres. CPT must be abolished, and their functioning can be stopped right now in an administrative way. It depends by the real will of doing it.

We will continue to struggle in order to demand and to obtain, starting from the force of migrants' protagonism, the end of every form of administrative detention, therefore the definitive closure of all detention centres; for the repeal of the Bossi-Fini Law, without going back to the Turco-Napolitano Law; for a law which recognize the instances which have been expressed by migrants' movement in the last years, first of all the uncoupling of labour contract and residence permit.

In order to repeat again these instances, we will be again in the squares next July 8, with a sit-in in front of the Internal Ministry, with clear demands on a national level

- **The repeal of the convention with the Poste, and of the agreement with Patronati and Anci,**
- **The immediate repeal of the applicative rules of the Bossi-Fini Law**
- **The immediate legalization of all the asimul seekers who had been refused by the central commission of asylum right.**
